

This personal data processing policy has been drawn up in accordance with the requirements of the Federal Law as of July 27, 2006 No. 152-FZ "On Personal Data" and determines the procedure for processing personal data and measures to ensure the personal data safety by the Operator on the Website <https://skinchanger.cc/>.

PLEASE READ THE TEXT OF THIS POLICY CAREFULLY. IF YOU DO NOT AGREE WITH ANY OF THE CLAUSES, YOU HAVE THE RIGHT TO STOP USING THE WEBSITE <https://skinchanger.cc/>.

As its most important goal and condition for its activities the Operator sets the observance of human and civil rights and liberties when processing personal data, including privacy protection, personal and family secrets. This Operator's policy in respect of personal data processing (hereinafter - the Policy) shall apply to all information that the Operator can receive about the website <https://skinchanger.cc/> visitors.

1. Terms and Definitions

Automated Personal Data Processing shall mean personal data processing using computer technology;

Personal Data Blocking shall mean temporary termination of the personal data processing (except in cases where processing is necessary to clarify the personal data);

Website shall mean a set of graphic and information materials, as well as computer programs and databases, ensuring their availability on the Internet at a network address <https://skinchanger.cc/>;

Personal Data Information System shall mean a set of personal data contained in databases and information technologies and technical means providing their processing;

Personal Data Depersonalization shall mean actions as a result of which it is impossible to define the personal data belonging to a specific user or another personal data subject without the use of additional information;

Personal Data Processing shall mean any action (operation) or a set of actions (operations) with personal data performed using automation tools or without using such tools, including collection, recording, systematization, accumulation, storage, clarification (update, change), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data;

Operator shall mean individual entrepreneur Naumova Olga Ernestovna individually or jointly with other persons arranging and (or) carrying out personal data processing, as well as determining the purposes of personal data processing, the composition of personal data to be processed, actions (operations) performed with personal data;

Personal Data shall mean any information relating directly or indirectly to a specific or identifiable Website user;

User shall mean any Website visitor;

Personal Data Provision shall mean actions aimed at the Personal Data disclosing to a certain person or specific persons;

Personal Data Dissemination shall mean any actions aimed at disclosing the Personal Data to the general public (Personal Data transfer) or at familiarization with the Personal Data of the general public, including the Personal Data disclosure in the media, posting on information and telecommunication networks or providing access to the Personal Data in any other way;

Cross-Border Personal Data Transfer shall mean the Personal Data transfer to a foreign state to the authority of a foreign state, a foreign individual or a foreign legal entity;

Personal Data Destruction shall mean any actions following which the Personal Data are destroyed irrevocably with the impossibility of further restoring the Personal Data content in the Personal Data information system and (or) following which the Personal Data material carriers are destroyed.

2. The Operator can process the following User's Personal Data:

Email address;

Phone numbers;

Taxpayer identification code, registration date, details of the certificate of registration with the tax authority;

Accounts in social media and messaging services;

Payment details of accounts in financial institutions (banks and payment systems), including but not limited to: Email, phone number, client number, wallet number, account number, masked bank card number.

The Website also collects and processes anonymized data about visitors (including cookies) using the Internet statistics services (Yandex Metrika and Google Analytics, and others). The above data hereinafter in the text of the Policy shall be united by the general Personal Data concept.

3. Purposes of Personal Data processing

The purpose of processing the User's personal data is to inform the User by sending Emails;

conclusion, performance and termination of civil contracts;

providing the User with access to services, information and/or materials contained on the Website. Also, the Operator shall have the right to send the User notifications about new products and services, special offers and various events. The User can always refuse to receive informational messages by sending an Email to the Operator at contact@skinchanger.cc with a mark "Disclaimer of notifications of new products and services, and special offers." Anonymized Users' data collected using the Internet statistics services are used to collect information about the Users' actions on the Website, to improve the Website quality and content.

4. Legal grounds for Personal Data processing

The Operator processes the User's Personal Data only if it is filled in and/or sent by the User independently via special forms located on the Website. The User agrees with this Policy by filling in the appropriate forms and/or sending his personal data to the Operator. The Operator processes anonymized data about the User, if it is allowed in the User's browser settings (cookies storage and JavaScript technology use are enabled).

5. The procedure for Personal Data collecting, storing, transferring and other types of Personal Data processing

The Personal Data safety processed by the Operator is ensured through implementation of legal, organizational and technical measures necessary to fully comply with the requirements of the current legislation in the field of Personal Data protection. The Operator shall ensure the Personal Data safety and take all possible measures to exclude access of unauthorized persons to the Personal Data. The User's Personal Data shall never, under any circumstances, be transferred to third parties, except for cases related to the current legislation implementation. In case of any inaccuracies in personal data, the User can update them independently by sending a notice to the Operator at the Operator's Email address contact@skinchanger.cc with a mark "Personal Data update". The term for the Personal Data processing is unlimited.

The User can at any time revoke his consent to the Personal Data processing by sending a notice to the Operator via Email at the Operator's Email address contact@skinchanger.cc with the mark "Revocation of consent to the Personal Data processing".

6. Cross-border Personal Data transfer

Before starting the cross-border Personal Data transfer, the Operator shall make sure that the foreign state where the Personal Data are supposed to be transferred, provides reliable protection of the rights of the Personal Data subjects. Cross-border Personal Data transfer to the foreign states that do not meet the above requirements can be carried out only, if the Personal Data subject consents in writing to such cross-border transfer of his Personal Data and/or performance of the agreement to which the Personal Data subject is a party.

7. Final provisions

The User can receive any clarifications on issues of interest related to his Personal Data processing by contacting the Operator via Email contact@skinchanger.cc. This document shall reflect any changes in the Personal Data processing Policy by the Operator. The Policy shall be valid indefinitely until it is replaced by a new version.
